How to use the Form

The completed and final Candidate Nomination Form (Parts A, B, and C) must be received by World Athletics by no later than **1 June 2027** (midnight CET). Forms received after the deadline will be ignored.

Candidates are requested to provide their **draft** Competency Statement (Part C) no later than **31 May 2027** midnight CET for review.

Candidates are advised that the Election Oversight Panel will not extend these deadlines in any circumstances and they should therefore not leave completing the Form to the last moment.

The Nomination Form has three parts (A, B, C).

This document includes Parts A and B.

Part C (the Competency Statement) is provided separately for each position available for election.

Each part must be completed and attachments must be provided as follows:

Part A: Candidate's identification, together with the following documents:

- Candidate's confirmation of Eligibility from the Vetting Panel
- Certificate of completion of the ethical compliance e-learning course for Officials

Part B: Member Federation's nomination, together with the following document:

- Copy of the Member Federation's resolution by its Executive Body, Board, or equivalent, approving the Candidate's nomination

Part C: Candidate's Profile and Competency Statement are provided separately for the three positions available (President, Vice President and Individual Council Member).

Please complete the relevant Form(s), subject to the position you are nominated for, and submit it together with the following material:

- Official campaign picture in high resolution (in standard image formats such as JPEG, PNG, HEIC, etc.)
- 2-min Candidate presentation video

*If you are nominating for multiple positions:

- Submit only one version of Parts A and B
- Submit a Competency Statement for each position you are nominating
- Submit a Candidate presentation video for each position you are nominating
