

229th World Athletics Council Meeting 29-30 November 2022 – Rome, ITA Information and Decisions

The Council of World Athletics chaired by President Sebastian Coe met on 29 and 30 November 2022 in Rome, Italy.

2. INFORMATION AND DECISIONS

2.1 MEMBER FEDERATIONS

2.1.1 Russian Athletics Federation

Following the Council's decision at its last meeting in July 2022 that an independent audit of the Russian Athletics Federation (RusAF)'s processes and progress against the agreed Reinstatement Plan and KPIs be conducted in October/November 2022, the World Athletics Russia Taskforce chaired by Rune Andersen presented an update report to Council on the progress made and the work undertaken with the auditors and the international experts.



RusAF's progress was acknowledged and evidenced by its reporting of historic anti-doping rule violations uncovered in the Moscow Laboratory Information Management System; by its delivery of the anti-doping education for 13,000 young athletes; and by having developed a test distribution plan that includes more than 2,000 domestic tests of Russian athletes per year (most out of competition). The Taskforce takes these developments as evidence that cultural change is starting to take root in Russian athletics but it was emphasised that widespread and sustainable cultural change would likely take many years to embed and would proceed at different parts of the system.

It was also emphasised that RusAF's progress on its reinstatement plan would have no bearing on any Council decision on RusAF's status arising from the war in Ukraine.

The Taskforce needs to finalise the proposed Post-Reinstatement Conditions with the Athletics Integrity Unit (AIU), including to reflect the audit report findings and recommendations. The Taskforce expects to be in a position to make a final recommendation to the Council on the reinstatement of RusAF at the next Council Meeting in March 2023, provided RusAF continues to make progress in reforming its culture.

The close monitoring and oversight of RusAF's operations would not end when its suspension from membership of World Athletics is lifted, but would be taken over by the AlU, which would enforce a detailed set of Post-Reinstatement Conditions, more stringent than those currently imposed on "Category A" federations (those regarded as most at risk of major doping issues). These conditions will be finalised with the AlU over the coming months and presented to the Council for approval before the Taskforce makes its final recommendation on reinstatement.

The Taskforce will also recommend that, to prevent backsliding or interference, any material breach of the Post-Reinstatement Conditions should trigger a Council proposal to Congress to expel RusAF permanently from membership of World Athletics.

2.1.2 Kenyan Federation

The Council discussed the ongoing situation with doping in Kenya in the context of the Athletics Integrity Unit's regular report. It was agreed that the Kenyan Government's commitment to provide an additional USD 5 million a year for the next five years to strengthen Kenya's anti-doping programmes was an appropriate response to the situation at this time. As Kenya remains a Category A federation under the World Athletics Anti-Doping Rules, the onus remains on Kenyan authorities to work closely with the AIU to ensure these funds are used effectively.

2.2 RULES AND REGULATIONS

2.2.1 Competition Rules

Upon the recommendation of the Competition Commission, Council approved the introduction of an official world record for the road mile from 1 January 2023. Prior to 1 September 2023, official recognition of a world record will require a performance of at least 3:50.00 (men) / 4:19.00 (women). If the listed standards are not met by 1 September, the fastest recorded, record-eligible performances will be recognised as the world records.

The amended Competition Rules will be available in the <u>Book of Rules</u> on the World Athletics website (Book C: Competition – C1.1 Competition Rules).

2.2.2 Technical Rules & Generally Applicable Definitions

Upon the recommendation of the Competition Commission, Council approved the proposed amendments to Technical Rules 1 and 11 and the definition of International Competitions and World Rankings Competitions (of the Generally Applicable Definitions). These amendments mandate that World Rankings Competitions



membership is required for National Permit Competitions wanting their results to be recognised by World Athletics.

The amended Generally Applicable Definitions and Technical Rules can be found in the <u>Book of Rules</u> on the World Athletics website (Contents, Rules of Interpretation, Definitions and Book C: Competition – C2.1 Technical Rules).

2.2.3 Honorary Member and Service Awards Rules

Upon the recommendation of the Governance Commission, Council approved the proposed amendments to the Honorary Member & Service Awards Rules effective from 1 December 2022. The amendments follow the Council's approval of the Nominations Panel recommendations regarding the procedures for nominations and are aimed at improving the criteria and nominations process to ensure a fair and consistent approach for nominations under the Rules.

2.2.4 Member Federation Rules & Area Association Rules

The new Member Federation (MF) Rules and Area Association (AA) Rules are required by the Constitution and set out the procedures for membership of World Athletics and respectively detail the rights and obligations of MFs (Article 9.1) and AAs (Article 20.1). The new rules therefore codify current procedures and practices between World Athletics and MFs and AAs addressing discrete issues such as the expectations concerning general meetings, safeguarding and resolving disputes.

The rules were developed by the Governance and Legal teams, in conjunction with the Governance Commission, and following an extensive consultation process. The consultation helped to shape the rules and develop the information and supporting documentation such as templates, forms and guidance that will sit alongside the rules to assist implementation and promote better governance.

Upon the recommendation of the Governance Commission, Council approved the new Member Federation Rules and Area Association Rules along with the framework and supporting documentation and tools. The suite of information will be rolled out ahead of the effective date for the new rules of 1 July 2023.

The new Member Federation Rules and Area Association Rules will be available in the <u>Book of Rules</u> on the World Athletics website (Book B: Organisation – B1 Member Federation Rules and B2 Area Association Rules).

2.2.5 World Athletics Indoor Tour Regulations

Ahead of the 2023 Indoor Tour Season and following a review of the current Indoor Tour Regulations, Council approved amendments to these Regulations to come into force on 16 December 2022. The key amendments concern mitigation against the risk of last-minute withdrawals from meetings of the World Indoor Tour and the introduction of the sustainability event standards.

The amended Regulations are available <u>here</u> on the World Athletics website (Book C: Competition – C1.5 Indoor Tour Regulations).

2.2.6 World Athletics Series Regulations and consequential amendments to the Neutral Athlete Regulations

At its July meeting, Council approved the principles concerning the restructure of the World Athletics Series Regulations incorporating applicable provisions from the Neutral Athlete Regulations. The current Regulations and Neutral Athlete Regulations can be found in the <u>Book of Rules</u> section on the website, (see Book C: Competition – C1.2 & C3.7).

The proposed restructured World Athletics Series Events Regulations and consequential amendments to the Neutral Athlete Regulations as approved by Council will be effective from 16 December 2022. As a reminder, the Regulations are for Member Federation teams, team officials and potential hosts and set out the essential competition ingredients to organise, stage and deliver a World Athletics Series Event. Regulations act as a reference point setting out World Athletics' policies concerning athlete quotas, delegates and officials travel and accommodation and who meet the costs of the same which is important for team administration and reconciliation purposes. The Regulations also act as the underpinning document to the Team Manual issued ahead of each WAS Event.

2.2.7 Start Procedure Guidelines

As part of an ongoing review of the start procedures, Council approved an amendment to the Start Procedure Guidelines to provide the Start Referee with the scope to evaluate the athlete's movement, the technological evidence and the discretion to permit the athletes to run "under protest":

4.5 (...)

If he (the Start Referee) is in any doubt, allow Athletes to run "under protest" [Rule 8.4.1 of the Technical Rules] if the SIS indicates an illegal start and there is good reason to suggest that the information is inaccurate, or there is an equipment malfunction. No protest will be allowed if the SIS is working correctly and a false start has been indicated. However, it is acknowledged that when the reaction time is close to the allowed limit, any movement could be hardly visible and, in this case, if in the opinion of the Start Referee it would require further study of the technological evidence, the Start Referee may decide to allow the athlete run under protest to preserve the rights of all concerned.

Referees and others must be aware that it is possible that the SIS may be working correctly but "incorrectly" indicate a false start – because motion by an Athlete that does not include or result in the Athlete's foot / feet leaving contact with the foot plate / plates of the starting blocks, or the Athlete's hand / hands losing contact with the ground, shall not be considered the commencement of the start.

(...)

The Council also noted that further general studies will be conducted concerning start procedures.

The amended Start Procedure Guidelines are accessible in the <u>Manuals & Guidelines</u> section of the website and are effective from the date of the Council's decision (30 November 2022).

2.2.8 Eligibility Regulations for the Female Classification (Athletes with Differences of Sex Development) ('the DSD Regulations') and Eligibility Regulations for Transgender Athletes ('the TG Regulations')

At an information session ahead of the Council Meeting, Council discussed an ongoing review of the current DSD Regulations and Transgender Regulations. A preferred option for both sets of regulations was presented to the Council members and it was agreed that this option would be considered more widely during a consultation period with Member Federations, athletes and other stakeholders over the coming months. The results of this consultation and a final recommendation will be presented to the Council for a decision at its March meeting. 2.3 WORLD ATHLETICS SERIES EVENTS

2.3.1 World Athletics Relays 2024

Upon the recommendation of the Bid Evaluation Panel, Council awarded the organisation of the 2024 World Athletics Relays to the host city of Nassau, The Bahamas and the Bahamas Association of Athletics Associations. This event will be held on 4 and 5 May 2024 and will be the main Olympic qualifying event for the men's and women's 4x100m and 4x400m relays and the mixed 4x400m relay.



2.3.2 World Athletics Road Running Championships

To continue to support the development of road running, especially the growth of road miles and 5km road races, the Council approved to change the current frequency of the biennial World Athletics Road Running Championships (WRRC), making it an annual event. The annual rotation will start in 2025 and the Pre-Qualification stage of hosting for the next two editions of the event (2025 and 2026 WRRC) was launched on 1 December 2022 (please refer to Circular M/57/22 for details).

2.3.3 World Athletics Road Running Championships Riga 23

Entry Rules

Council approved the proposed Entry Rules for the World Athletics Road Running Championships Riga 23 as follows:

WRRC Riga 23 Entry Rules	
Max no. of athletes each MF can enter in each event:	Half Marathon: Up to 4 per gender. 5k: Up to 2 per gender. Road mile: Up to 2 per gender*.
WA standards:	No entry standards

* Given the dimensions of the start as well as the relatively short distance, it may become necessary to limit the total number of entries in the road mile – this will be confirmed following agreement of the revised mile course.

2.3.4 World Athletics Cross Country Championships Medulin / Pula 24

Council approved the proposed dates for the 2024 World Athletics Cross Country Championships in Medulin / Pula, Croatia as 10-11 February 2024.



2.3.5 World Athletics U20 Championships Lima 24

Council approved the revised dates for the 2024 World Athletics U20 Championships in Lima, Peru as 26-31 August 2024 (from the previously submitted dates 20-25 August 2024).

2.3.6 World Athletics Championships Tokyo 25

Council approved the proposed dates for the 2025 World Athletics Championships in Tokyo, Japan as 13-21 September 2025.

2.3.7 Delegates' Appointment

Council approved the delegate appointments for the following WAS Competitions:

- World Athletics Championships Budapest 23
- World Athletics Cross Country Championships Medulin/Pula 24
- World Athletics Championships Tokyo 25

In approving these appointments, Council reinforced the importance of accelerating the recruitment process of delegates to ensure a greater gender and area representation.

The full list of approved delegates for these events can be found in Appendix A.

2.4 WORLD RANKINGS

2.4.1 Annual review

Following the annual review of World Rankings, Council approved the proposed changes to the current World Ranking rules and recommendations concerning the management of one-day meetings, as set out below:

Cross-Country Rankings	 The disproportionate number of meetings in the Gold category compared to the lower Silver and Bronze (respectively 15, 3 and 4) means that the performance scores tables initially determined for the Cross Country Rankings are not appropriate. It was agreed that: the tables be re-adjusted to ensure a correct scoring the issue of the disproportionate distribution between Gold, Silver and Bronze be addressed.
Ranking points for Olympic and World Championships (OW category)	Too many competitions have been upgraded in the recent past and the gap with the OW category has decreased. To re-establish a proper and proportionate reward for OG and WCH finalists, it was agreed to review and increase the placing score table, accordingly, limited to the top 8. Additionally, limited to the events with a ranking period of 18 months, it will be possible for two OW category competitions to count (the older one with GL category ranking points to avoid overweighting).
Indoor Field Events	With the expansion of the World Indoor Tour and increased popularity of indoor competitions, keeping indoor field events as similar events in the world rankings is no longer appropriate. It was approved that indoor HJ, PV, LJ, TJ and SP be considered as main events in the minimum number of performance scores required.
Combined Events Tour	In 2021, selected Gold level meetings (Götzis, Talence and Ratingen) offered higher ranking points (GL category instead of A) however the gap between the best and the others in terms of quality of the participating field has increased. It was agreed that only Götzis (which remains by far the best) and Talence (on



	trial basis for another year) award GL ranking points, while Ratingen joins Multistars and Arona awarding category A ranking points.
Road Mile	It was approved that the road mile be considered as a similar event in the 1500m event group (like the track Mile).
One-day meetings membership, events programme, and prize money structures	The Continental Tour in particular is playing a growingly important role in the athletes' World Rankings and ensuring the integrity of access to the placing points available across the different categories is very important. It was agreed that:
	 Tour membership and events programme (and consequently prize money offering) be announced well in advance (at least 60 days like for World Rankings Competitions) That prize money at the different levels of meetings be maintained according to the category of the meeting (other than for strictly national events) throughout 2023 but for this group to discuss a proper and clear framework for this to be possibly implemented from 2024.

2.4.2 World Rankings Competitions

Following the Council's approval of Technical Rule changes required to implement the World Rankings Competitions framework (see section 2.2.2 of this Circular), Council acknowledged the implications in terms of results processing on behalf of World Athletics and approved the terms and amount of an Administration Fee for each competition application as follows:

that an administration fee of 25 EUR (equivalent to 25 USD) be charged for each competition
application submitted through the Global Calendar online platform (excepted for official annual national
championships (of all age groups and for any event) and other competitions organised and funded
directly or indirectly by the Member Federation). The process will start with competitions taking place
from 1 March 2023 onwards.

Further detail on the implementation of the World Rankings Competitions framework, including on the operation of the Global Calendar platform and timelines is set out in Circular M/60/22 dated 12 December 2022.

2.5 PARIS 2024 OLYMPIC GAMES

Qualification System and Entry Standards

Council approved the revised Qualification Window for the Paris 24 Olympic Games, as well as the proposed Qualification System and Entry Standards as attached in Appendix B.

Race Walking Mixed Team Event

Council discussed and approved a proposed revised format of the race walking mixed team event for the Paris 2024 Olympic Games in line with IOC and OBS requirements. The proposal, as set out below, has been forwarded to the IOC for further review and confirmation and the final format will be communicated to Member Federations as early as possible.

2.6 SAFEGUARDING

As decided by Council in July 2022, the World Athletics' Safeguarding Policy now includes the requirement for Member Federations to have a safeguarding policy and procedures in place by December 2023. The new Policy has been translated into French and Spanish and is available on the <u>Safeguarding section of the website</u>.

As previously communicated, specific Safeguarding Materials have been developed for Member Federations and Area Associations to assist with the development and adopting of their own safeguarding policies and procedures. A new video called "How to Create a Safeguarding Policy" has been produced by World Athletics to make these Safeguarding materials more accessible and create a better understanding of how to utilise them. Further details are provided in Circular M/58/22 dated 2 December 2022.

Council approved the proposed case management approach to deal with safeguarding cases. Council also approved the proposed principles underpinning the creation of new Safeguarding Rules, which will be drafted in consultation with the AIU, and which will also require amendments to other rules and regulations including the Integrity Code of Conduct and AIU Rules. The new Safeguarding Rules and proposed corresponding rule amendments will be submitted to Council for review and approval at its March 2023 meeting.

2.7 ATHLETES' COMMISSION

An update was provided on the work of the Athletes' Commission and their key objectives for 2023. These include a greater focus on enhancing and further expanding interaction with the global athlete community, maintaining strong athlete representation in World Athletics' decision-making processes and promoting the rights and interests of all athletes.

The Commission has set the goal to collaborate with Areas Associations and Member Federations to encourage the set-up of their own Athletes' Commissions. Using the data derived from the 2022 Annual Report Form on the status of Member Federation Athletes' Commission worldwide, the Commission is assigning dedicated liaisons among its members to establish clear communication pathways and to consult more effectively with athletes around the world.

2.8 DEVELOPMENT COMMISSION

The Council received an update on work undertaken by the Development Commission and the key topics and priority areas which included:

- Progress of the <u>Kids' Athletics programme</u>, where the focus has been on encouraging MF engagement and the development and roll out of the train the trainer and practitioner workshops. Kids' Athletics Day will be held on 7 May 2023 and information will be circulated to Member Federations in the new year.
- An update on the eLearning platform and the courses that have been recently launched (Safeguarding, Ethical Compliance and the WA Referee Silver Evaluation) and those to be launched by the end of March 2023 (CECS L2, Kids' Athletics Practitioner, Administration). The eLearning platform can be accessed <u>here.</u>
- The implementation of the new World Athletics Referee Education and Certification System (WARECS)
 pathway and the WA Referee Silver level evaluation, which was held online for the first time on 5 November
 with over 400 participants. The experience acquired during this first worldwide online evaluation and the
 analysis of the feedback and technical issues faced will inform the development and implementation of
 future exams.
- An update was provided on the roll out of the new development model framework and principles and the successful pilot of the online World Athletics Grants Hub. The Grants Hub will be used for all grants in 2023 and further detail will be provided in a separate circular.



2.9 WORLD PLAN FOR ATHLETICS

An update was provided on the work of the World Plan Implementation Working Group whose focus has been to further communicate the World Plan and seek feedback from Member Federations on progress to date and support needed for implementation. Five core workstreams have been established by the Working Group to support successful implementation of the World Plan as follows:

- Monitoring & reporting
- Communications & engagement plan
- Identify good practice & successful examples
- Develop "short form" plan & messaging and templates
- Promote Plan & Feedback MFs /Areas

The Working Group will continue its work to support, encourage and ensure all stakeholder groups are aware and equipped to contribute to the delivery of the World Plan and will review and report to Member Federations in 2023. All Member Federations will be asked to provide an update on progress against actions in the World Plan through the Annual Report Form.

B.3. Type of allocation of quota places:

Quota places are allocated to the athlete(s) by name in individual events. If an NOC has more than three (3) qualified athletes in individual events, the NOC can decide which of these athletes will receive the quota places. Quota places are allocated to the NOC(s) in the relay, team events and, to some extent, also in the marathon (subject to conditions as described below).





C. ATHLETE ELIGIBILITY

C.1. Compliance with the Olympic Charter and other relevant rules:

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of World Athletics, may participate in the Olympic Games Paris 2024.

C.2. Age requirements:

To be eligible to participate in the Olympic Games Paris 2024, athletes must the following age requirements:

Senior athletes	Any athlete aged 20 on 31 December in the year of the competition (born in 2004 or earlier) may compete in any event
U20 athletes	Any athlete aged 18 or 19 years on 31 December in the year of the competition (born in 2005 or 2006) may compete in any event except the Marathon and 35km Mixed team Race Walk.
U18 athletes	Any athlete aged 16 or 17 years on 31 December in the year of the competition (born in 2007 and 2008) may compete in any event except the throwing events, Heptathlon, Decathlon, 10,000m, Marathon and the Race Walk events.
Athletes younger than 16	No athlete younger than 16 years of age on 31 December in the year of the competition (born in 2009 or later) may compete at the Olympic Games.

C.3. IF additional eligibility criteria/requirements:

Athletes must also comply with the following criteria:

• Adhere to the rules outlined in World Athletics' Eligibility rules (Book C 3.3).

D.2. UNIVERSALITY PLACES (UNQUALIFIED ATHLETES)

An NOC with no male or female qualified athlete or relay team will be allowed to enter their best ranked male athlete or their best ranked female athlete in either the 100m, 800m or Marathon. This applies equally to unqualified female entries from an NOC with qualified males, and vice versa.

Unqualified entries in the 800m will be limited to three (3) in each gender and acceptance will be at the discretion of the World Athletics Technical Delegates, based on the technical standard of the athlete.

A specific application form indicating the event in which the entry is requested, and the proof of the technical level and international participation of the nominated athlete, must be submitted to World Athletics.

World Athletics shall subsequently confirm, in writing to NOCs, with a copy to the Paris 2024 Sport department, the approval or otherwise of the entry of the specified athlete(s).





The application forms of all unqualified athletes must be submitted by NOCs to World Athletics no later than 31 May 2024.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

Following the end of the qualification period, World Athletics shall confirm the number of athletes having achieved the entry standard plus the approved unqualified athletes and shall subsequently determine the athletes qualified by virtue of their World Athletics World Rankings position.

The list of qualified athletes for each event, and including the relay teams, shall be published in the Road to Paris on the World Athletics <u>website</u> on 2 July 2024.

F. REALLOCATION OF UNUSED QUOTA PLACES

F.1. REALLOCATION OF UNUSED QUOTA PLACES

After publication of the qualified athletes on 2 July 2024, NOCs must inform World Athletics of their intention to decline a quota place, whether in individual or relay events, by the deadline of 4 July (midnight Monaco time). Notifications must be sent to <u>teamservices@worldathletics.org</u> by the NOC/Member Federation concerned, with a copy to its respective NOC. Quota places declined after the above deadline will not be reallocated.

During the period 4 - 6 July, World Athletics will reallocate the declined quota places to the next best ranked athlete in the same event according to the World Athletics World Rankings, respecting the maximum quota by NOC per event. In case of tie (same world ranking position and ranking score), this will be resolved in favour of the athlete with the next best performance score.

If an allocated team relay quota place is declined by the NOC, the quota place will be reallocated to the NOC whose relay team has recorded the next fastest time in the qualification period in accordance with World Athletics' criteria for the qualification of relay teams.

On 7 July 2024, World Athletics shall publish the last edition of the Road to Paris with the final list of all qualified individual athletes and relay teams eligible for final entry. NOCs shall enter all athletes to Paris 2024 by the entries deadline of 8 July 2024.

F.2. REALLOCATION OF UNUSED UNIVERSALITY PLACES

There will be no reallocation of Universality places

G. GENERAL PRINCIPLES OF RESERVE AND AP ATHLETES

G.1. RESERVE ATHLETES





Reserve athletes are competing athletes who have an Aa accreditation and who are entered by their NOC in a specific event where they have qualified.

As reserve, they may be selected to replace another entered athlete in a different event until the time of the final confirmation for that event provided:

- they were nominated as reserve for that event at the time of the final entry deadline
- they have achieved the entry standard or have qualified by virtue of their World Athletics World Rankings position
- that the NOC quota for that event is respected

Reserve athletes must comply with the same eligibility rules as competing athletes as described in above paragraph **C. Athlete Eligibility**.

G.2. AP ALTERNATE ATHLETES

Ap alternate athletes are non-competing athletes and are not included within the athletes' quota as described in paragraph **B. Quota Places**.

If an NOC has entered three athletes in one event, they are entitled to nominate one Ap alternate athlete for the same event provided:

- he/she was nominated as alternate for that event at the time of the final entry deadline
- he/she has achieved the entry standard or has qualified by virtue of the World Athletics World Rankings position

Ap alternate athletes must comply with the same eligibility rules as competing athletes as described in above paragraph **C. Athlete Eligibility**. Ap alternate athletes can only become competing athletes as per the conditions outlined in the Late Athlete Replacement policy.
