- Has competed in at least one of the last two World Athletics Championships, or in the last Olympic Games, or is a competitor in the World Athletics Championships at which the election is being held;
- Is able to speak and understand English reasonably well;
- Has been declared eligible by the Vetting Panel in accordance with the Vetting Rules.

In the event a Candidate who has otherwise complied with all the EOP's requirements, but has not received the nomination of their Member Federation by the deadline (for whatever reason), the amended Candidacy Rules, effective 13 December 2024, provide that "if the candidate has indicated in their completed Candidate Application Form that endorsement by their Member Federation's has not been provided, the Election Oversight Panel will notify the candidate's Member Federation in writing of the proposed candidature to verify whether there are valid reasons for not endorsing the candidature. The matter will then be reviewed by the Election Oversight Panel who will decide on the matter and contact the athlete and Member Federation within a specified time period. There will be no right of appeal to the Election Oversight Panel's decision."
